### **Practice history:**

1994-Present: Lawrence Plastic Surgery, P.A.

Founded the practice in 1994 as the first plastic surgery practice at a community hospital that serves a population of approximately 100,000. During that time we have built a strong presence in the region and have now served over 23,000 patients from 35 states and 7 countries.

Although our initial training was broadly based, we have come to focus our practice in the following areas that best fit the needs of our community and our interests: **Breast Surgery** 

- Introduced breast reconstruction into the community and worked closely with general surgeons to develop and refine techniques in immediate reconstruction following skin/areolar/nipple sparing mastectomies, oncoplastic surgery, autologous tissue reconstruction utilizing TRAM and latissimus dorsi flaps, tissue expander/implant reconstruction, utilization of acellular dermal matrices, autologous fat grafting, and other techniques.
- Headed the effort to develop a Breast Center at Lawrence Memorial Hospital to coordinate the efforts of General Surgery, Plastic Surgery, Oncology, Radiation Oncology, Pathology, Radiology, genetic counseling and other services to provide better structure to the treatment of breast cancer patients.
- Worked with insurance companies to obtain reimbursement for the use of acellular dermal matrix products in breast reconstruction when this was considered an experimental technique and routinely being denied coverage. It is now considered a standard option in treatment.
- Performed outreach in communities outside of the Lawrence area to educate providers and the public on breast reconstruction and breast surgery. This resulted in a significant referral base primarily in the northeast Kansas region (Topeka, Junction City, Manhattan, Emporia) as well as from areas in the western and southern parts of the state.

- Introduced breast reduction surgery to Lawrence and have become regionally recognize for expertise in this procedure.
- Developed a strong practice in cosmetic breast surgery, complimenting our work in reconstructive surgery.
- Currently serve as the sole plastic surgeon on the Surgery Liaison Committee of Blue Cross/Blue Shield of Kansas to provide input and help develop medical coverage policies related to reconstructive breast surgery.

# **Body Contouring**

- Introduced the techniques and procedures of abdominoplasty, panniculectomy, liposuction, brachioplasty, body lifting, surgery after massive weight loss, and drainless abdominoplasty and other procedures to the local hospital and community. We are now regionally recognized for excellence in the region for these procedures and draw both cosmetic and reconstructive patients from a broad area.
- We have focused on safety with these procedures and have given several presentations at national meetings on this topic at national meetings, particularly on the avoidance of DVT/PE.

# **Facial Surgery**

- Developed a strong practice in both cosmetic and reconstructive facial surgery. We have become regionally recognized for our expertise in facelifts, necklifts, limited incisions facelifts, blepharoplasty, and other cosmetic facial procedures.
- Presented at national conferences describing our procedures in necklifting when this was an emerging technique in 2005.
- Have performed a wide range of facial reconstructive procedures including traumatic repair, scar revision, tumor removal, and functional eyelid surgery.
- Established a reputation among patients and providers for both functional and cosmetic blepharoplasty as well as other eyelid procedures.

# Trauma

- Since arriving in 1994 have assured that the Emergency Department at Lawrence Memorial Hospital was provided with continuous coverage by a plastic surgeon. This enabled the hospital and community to receive plastic surgical services in a timely fashion and avoid transfer to other facilities.
- Managed both the acute stages of treatment as well as long range complications of a wide range of injuries.

# Skin Care and Skin Cancer

- Developed a strong reputation in the Lawrence and Topeka area among dermatologists and primary care physicians for the treatment of skin conditions such as complex skin cancers, scars, closure following Mohs' procedures, melanoma treatment, and other conditions.
- Recognizing the role of non-surgical treatment in aesthetic plastic surgery we hired the first medical esthetician in the region in 1998 and continue to offer non-surgical options for cosmetic enhancement
- Introduced dermatologic laser treatment to the Lawrence/Topeka region, purchasing our first device in 1997.
